OBJECTIVES OF THE INTEGRATED COURSE: by the end of the course, students will be able to describe the organisation of health services by analysing the principles underlying their management, and by focusing on the dynamics and essential elements that allow the organisation of patient care with the different care processes provided by the multi-professional care team. The course will also look into professional responsibility, rights, obligations and sources regulating employment legislation.

TEACHING METHOD: Lectures, guided discussions, exercises.
